FLOWER CHILDREN RULE THE WORLD

Remember the Flower Children? Back in the ancient 60's, they were the folks who believed that life, love and hope would change the world. It was the Age of Aquarius! In a political sense, the Flower Children believed in the power of government to effectuate a new world order based upon the power of positive bureaucracy. Democrats were said to embrace this philosophy and Lyndon Johnson was the apostle of impact legislation.

The Republican minority was shrinking. Republicans touted the wishes of the Founding Fathers to preserve state and local government against intrusion by Washington, D.C. Instead, Congress decided to abrogate the entirety of state control over local affairs so that the Schiavo parents could claim that removing a feeding tube from their daughter, who is in a vegetative state, represents a violation of an ambiguous federal right to be kept alive.

The *Schiavo* law invitation to judicial activism is hypocrisy in the extreme. It represents a breathless assumption of state law by the federal government. What is Dr. Bill Frist thinking? How to become President by exploiting the suffering of Terry Schiavo?

In a word, the rampant radicals in Congress would stop at nothing to intrude upon, trample or control every aspect of an individual's life so long as it suits a grandiose social philosophy dictated from Washington, D.C.
