Clash of Titanic Egos:

Comey v. Trump

Doubtless, lives have been lost because of secrets accessed by our enemies and used against us in the field of battle from Afghanistan and Iraq to the African continent. The distressing truth is that war has been waged against us by regimes that not only have no respect for democracy but also see the American way of life as a threat to their own. We have plenty of rot from within, exacerbated by those who are interested in "bringing down" the slumbering giant; America.

Long-winded hearings will continue, leaks will turn into floods, and the opponents of Donald Trump will focus more on their opposition government than what is good and safe for the United States. The "loyal opposition" has every right, and even more so a responsibility, to voice their concerns and outrage.
